## 3M<sup>™</sup> Drive-Thru Basestation G5

Wiring a D-15 as a Backup Communication System to the 3M<sup>™</sup> Drive-Thru Basestation G5 using an External Backup Switch

### Overview

A backup Intercom system is a wired or wireless communication system that can be used as a backup in the unlikely event of 3M<sup>™</sup> DriveThru Basestation G5 failure.

In August of 2016, 3M sold the Wired Communication Products including the D-15 Intercom to RDM Industrial Electronics, Inc. (RDM). Unlike the 3M<sup>™</sup> Wireless Communication System Model XT-1, the 3M<sup>™</sup> Drive-Thru Basestation G5 does not have a built-in backup switch. RDM has developed an external Backup Switch to integrate the D-15 with 3M<sup>™</sup> Drive-Thru Basestation G5. 

- **NOTE:** The D-15 Backup Switch is designed to provide backup communication any ONE lane ONLY. In the event the store has a Dual Lane G5 Basestation in operation, you may choose to install the D-15 Intercom as a backup system on either Lane1 OR Lane2.

### **Pre-Requisites**

This Technical Bulletin assumes the following:

- Installed the D-15 Intercom as a backup, per instructions provided in its installation manual, and
- Installed the D-15 Backup Switch per instructions provided and is ready to be wired, and
- Installed the 3M<sup>™</sup> Drive-Thru Basestation G5 per instructions provided in the 3M Installation Manual, and Installed an External Vehicle Detector for Order Point Vehicle Detection.


## Simple Block Diagram






## Connecting the D-15 Intercom System to the Backup Switch
